#### Status Update

Members of this workgroup regularly interact as part of the ongoing work of the NHD Stewardship Program. (We have not held a stand-alone CA GIS Council NHD Workgroup meeting.)

Work on bringing the 1:24,000 scale NHD data into NHDPlus is progressing and the NHDPlus High Resolution dataset for California is expected to be released in beta in summer-fall of 2019. DWR (Jane) is presenting on NHD Stewardship at the Central Valley GeoSummit at UC Merced on March 15. DWR (Jane and John Lance) will present on NHD Stewardship at CalGIS 2019 in Fresno, April 8-10. USGS (Carol Ostergren and Drew Decker) will present a Mini-Workshop on Getting to Know the NHD at CalGIS as well.

DWR (Jane) is preparing a one-day workshop for internal staff on NHD. The first offering will be in early summer. Afterwards, we are willing to present the workshop at other sites. Please contact Jane to arrange a workshop offering at your venue.

USGS released its Markup Application that allows anyone to submit corrections or additions to the NHD and the Watershed Boundary Dataset. The application runs in the Chrome browser and requires a gmail account or an ArcGIS Online account. The Tribal outreach meetings originally planned for January did not happen; we are awaiting word on rescheduling.

DWR launched a project to add names of water features that already exist in the USGS' Geographic Names Information System (GNIS) into the NHD. DWR (Jane) met with folks from USGS GNIS and the Board on Geographic Names on March 5 to discuss the most efficient way to submit proposed names to the GNIS. Names cannot be added to the NHD unless they already exist in the GNIS. Anyone who has names of water features currently missing in NHD may contact Jane, and the DWR team can prepare the proposal. Many thanks to Fran Evanisko who contributed volunteer work on this effort!
