10:20 – 11:15 Proposed Charter Revision and Integration with the California Geographic Information Association (CGIA) - discussion led by Jane Schafer-Kramer, Chair The proposed revised charter is attached to this agenda.

The mission of CGIA is posted on its website at <a href="https://cgia.org/about-cgia/mission/">https://cgia.org/about-cgia/mission/</a>

"Based on the Adopted CGIA By-Laws, CGIA's mission is to promote the effective use of GIS by pursuing the following goals:

- Encouraging appropriate, coordinated, and cost-effective use, acquisition, exchange, and management of geographic information in the state of California
- Promoting the use of consistent standards, procedures, and mechanisms for ensuring the accuracy and quality of geographic information used and created by public and private entities in California
- Supporting and promoting the practice of GIS
- Monitoring developments in the field of GIS and informing the membership of same
- Serving as a resource for its membership
- Providing a forum for the exchange of ideas and information

This mission is implemented each year by the completion of tasks related to specific strategic initiatives, objectives, and action plans. The Board adopts initiatives with input and feedback from CGIA members. CGIA produces an annual report that summarizes key accomplishments for fiscal year (July to June), prepared in June of each year and posted on the CGIA web site."

#### Motion #1

Jane Schafer-Kramer - The Charter Review and Strategic Plan Workgroup formed in 2019 to begin the year 5 review of our Charter. I volunteered to lead it because I was Vice Chair at that time, and I saw that there are elements of our Charter that have not become reality and are not likely to. When the Charter was adopted in 2015, we aspired to "act as an advisory body to members of its constituencies, the State Geographic Information Officer, and agencies and groups that develop and implement geospatial initiatives, policies, and standards, by providing recommendations, best practices, and expertise." In retrospect, this group did endorse two reports: Maintaining Geodetic Control for California – Strategic Assessment approved by the Council December 14, 2017 <a href="http://cgia.org/cagiscouncil/wp-content/uploads/2018/01/Maintaining-Geodetic-Control-for-California-19-18.pdf">http://cgia.org/cagiscouncil/wp-content/uploads/2018/01/Maintaining-Geodetic-Control-for-California-19-18.pdf</a>, and A Shared Vision for the Survey of California Vegetation, <a href="http://cgia.org/cagiscouncil/wp-content/uploads/2015/06/A-Shared-Vision-for-the-Survey-of-California-Vegetation.pdf">http://cgia.org/cagiscouncil/wp-content/uploads/2015/06/A-Shared-Vision-for-the-Survey-of-California-Vegetation.pdf</a>. I sincerely hope that our endorsements had a positive effect. Other than these instances, I have not observed that this Council has a real advisory role to anyone other than us. Our members have shared their visions of what this Council could be, but it has been a real struggle to get

volunteers to take leadership roles. Most of our workgroups are not functioning as actual workgroups, but rather as a means of reporting out on activities of interest to the community. This Council has functioned as a forum for sharing information on topics related to our work and to the development of statewide framework geospatial datasets. That role as a forum is valuable to us, and worth the effort to continue. Our aspirations to influence policies and implement standards have not played out and are not likely to in our current form. Another reality we acknowledge is that we need some support to improve our website and communications resources. We are not a non-profit organization, nor do we have a government sponsor. We do have some support by the California Geographic Information Association (CGIA) in the form of a basic website, and we are grateful for that. Discussions in the Charter Review and Strategic Plan Workgroup and in our Executive Committee have led us now to propose some changes in the Charter to reflect our reality and guide us forward. We have also discussed our hope that CGIA, which is a nonprofit organization with similar mission and goals, would be willing to work more closely with us. Many Council members are also members of CGIA, and some are serving or have served on the CGIA Board of Directors.

Melissa Christie - Motion to get CA GIS Council membership approval to begin discussions with CGIA on integrating the CA GIS Council.

Jacob Mark - Seconded the motion.

#### Motion discussion:

Jane Schafer-Kramer - Name change part of first draft charter revision. Name change removed from second draft of charter revision due to membership disagreement about name change.

Chris Robinson – CGIA board discussions mostly positive. Believes that we can do more together.

Bruce Joffe – Agrees council hasn't met goals. This is the fourth iteration of a CA GIS Council. CGIA has always advocated for a council. Bruce was Involved with earlier geodetic control report with Scott Martin they looked to the CA GIS Council for support. Support eventually came from Caltrans. Time now to move to CGIA.

Jacob Mark – As chair for the CA GIS Council Policy Advisory Workgroup, Jacob is looking forward to CGIA integration.

Nathaniel Roth – Little Hoover Commission recommended a GIS advisory council. Is there indication CA GIS Council is standing in the way of an official advisory council?

Jane Schafer-Kramer – CA received a B- grade on the NSGIC 2021 Geospatial Maturity Assessment Report Card. A question on the report card survey asked "Does your state have an active GIS coordinating council that meets at least 4 times a year?" The GIO answered the question with "Yes, an unofficial but active council".

David Harris (chat): NSGIC Geospatial Maturity Assessment https://nsgic.memberclicks.net/assets/GMA/2021/2021\_December\_10\_GMA\_FINAL.pdf Nathaniel Roth – What will CGIA integration look like related to CA GIS Council identity and function? Jane Schafer-Kramer – There has not been official integration discussion with CGIA yet. One option mentioned during preliminary discussion did not require CA GIS Council members to pay CGIA dues. Current CGIA membership dues are \$50/yr.

Nathaniel Roth - Recommended Executive Committee to identify priorities of the CA GIS Council.

Svetlana Smorodinsky – Will CA GIS Council have to pay dues?

Jane Schafer-Kramer – One option mentioned was to require Chair, Vice-Chair, and Executive Committee members to pay CGIA dues, but not general members.

Mark Greninger – CA GIS Council tends to be more employment related focused whereas the decision to join CGIA is personal. CGIA should continue to advocate for official council. Mark is interested in how CGIA will fold in non-due paying CA GIS Council members.

Bruce Joffe (chat) - Good analysis, Mark G.

Jane Schafer-Kramer – There is concern from some that involvement in the CA GIS Council could be construed as employer representation and approval.

Mark Greninger— This iteration of the CA GIS Council covers all constituencies and the closest it has been to official than in the past.

Bruce Joffe (chat) - Let's keep his remarks in mind (they have been recorded) as we go forward to reorganize our mission with CGIA.

Mary Hurley – CGIA worked on past advocacy for GIO position. CA GIS Council could be integrated, streamlined, and operate as before. Mary would prefer for CA GIS Council leadership to become CGIA board members.

Donna Miranda-Begay — Concerned about CGIA's lack of tribal government representation on its board.

33 Votes, Yes: 76%, No: 3%, Abstain: 21%

#### Motion #2

Jane Schafer-Kramer - We presented proposed changes to the Charter at the December 2021 meeting. The proposed name change from California GIS Council to California GIS Community Forum sparked the most discussion. We posted the revisions on the Council website and opened a discussion forum; we received one comment (other than the ones I added.) The Executive Committee met on Feb. 16 and decided to revise the proposal by incorporating comments from the December meeting and the website forum, but leaving the name as-is for now, since that was the area where we did not see

consensus. We recognized that if we do integrate into the CGIA organization, then the CGIA leadership and board may want to decide our new name, or no name change at all. The major change in this proposal now is to remove the elected status of Council leadership. The Executive Committee would become a Steering Committee, and that would be made up of volunteers. The Steering Committee would decide who among the Committee will serve as Chair and Vice Chair. The language related to Workgroups is changed to reflect how they have been actually functioning. Other changes I would categorize as wordsmithing for flexibility's sake. The Strategic Plan called for in the original charter never materialized, so we propose removing that section.

Mark Greninger – Does it make sense to have a charter if integrating with CGIA?

Jacob Mark – Charter revision could help either way.

Mark Greninger - Motion to postpone CA GIS Council Vice-Chair election until CGIA integration discussion completed.

David Harris - Seconded the motion.

Motion discussion:

Bruce Joffe – Suggested amendment to Mark's motion to keep workgroup changes.

Mark Greninger – Motion includes postponement of any charter revisions. Continue the council as is until CGIA integration discussion is completed.

Nathaniel Roth – Asked if Jane and Chad OK with postponing election.

Chad Miller – Yes, OK with continuing as is until CGIA integration discussion completed.

Jane Schafer-Kramer – Prefer for Chad to become Chair in June and support as needed.
