AB 2022 - California Assembly (20212022) - Open States — Introduced 2/14/2022, proposed Natural Resources Agency established the California Advisory Committee on Geographic Names (CACGN) to be a liaison to the United States Board on Geographic Names. AB2022 proposes for the name "Sq _ _ w" to be removed from California geographic feature.
