#### **II. MEETING MINUTES APPROVAL**

#### **III. INTERNAL BUSINESS**

- Mary was asked if she was willing to continue as Treasurer and was approved via vote of the Board
- Norman was asked if he was willing to continue as Secretary and was approved via vote
  of the Board
- New Board member is introduced Jacob Mark
- Current committee members have been updated and are listed on our website.

## 1. Treasurer's Report

- Balance: \$41,522. Denise was reimbursed \$350 for the MembershipWorks renewal in August.
- Few people canceled. Some people were not aware that it's set to auto-renew on PayPal.
- Mary received a notice from PayPal that deposits of \$600+ will be reported to the IRS.
   Mary will update the nonprofit status on PayPal.
- For tax reporting purposes, CGIA is currently using the short form. If we go over \$50,000 CGIA will need to use the long form. Mary will speak to the CPA regarding its implications.

## 2. Standing Committee Reports:

#### A. Membership (Denise)

- July 1-August 31: 26 renewals, no new members, 3 student members are no longer students.
- Denise refunded the 3 students and had them pay regular fees. However, only 1 renewed.
  - As an idea, we should just keep them at the student rate and upgrade them to regular member the following year.
  - Everyone is notified from Paypal and MembershipWorks 30 days prior that they will be charged.
  - Denise has been trying to capture affiliation during their renewal.

## B. Website (Norman, Steve S., Bond, Zachary)

#### C. Advocacy (Chris, Mihai, Mary)

- CA GIS Council had its quarterly meeting last Thursday. All committees gave their update.
- Isaac (State GIO) has started working on updating the state strategic plan. Jane Schafer-Kramer gave him list of items that the council has been working on.
- CA GIS Council meeting minutes have been posted on website so please refer to it if interested.



- Jacob Mark will be updating us on the CA GIS Council at the next meeting.
- Fire evacuation mapping for the State presents an opportunity for GIS in the state
- D. Awards (Chris, Christine)
  - CalGIS will be postponing the conference to Spring 2022. No word from URISA so we don't know about the status of CalGIS.
  - There are currently 5 award nominees. An-Min suggested that we roll over nominees to next conference, possibly ESRI UC.
  - Chris will put out a statement to the nominees letting them know of this change.
  - We still need some more marketing to advertise awards, especially since there is money attached to it.
  - An-min: Since in-person classes have started, we should be able to target students
  - Dave P.: Is there any way to showcase the winners? Businesses would be interested in some recognition. For example, with URISA and others
- E. Elections (Dave, Steve K.)
  - 4 nominations are uncontested (Steve, Denise, and An-Min + Jacob Mark).
  - There are many vacant positions.
  - Norman will check with Christine Lam to see if she is continuing to be County rep (came in last year)
  - How to we drum up more participation? Lack of conferences is hurting us, but other organizations are in a similar bind. Information overload and too many virtual meetings are also contributing factors.
    - Membership is not lacking, it's engagement.
    - Mary said we need to reach out much earlier and look for people who are interested.
    - O How much outreach do we do to our membership?
  - We also lost Jayme as a Board member
    - Mary can ask Jayme to continue to post to social media.
- F. Communications (Jayme, Rachel)

  - Jacob Mark volunteered to be on this committee and potentially for advocacy
