#### **II. MEETING MINUTES APPROVAL**

#### III. INTERNAL BUSINESS

#### 1. Treasurer's Report

- Balance: \$44,210. Received PayPal notification. Sent a check for Mark Greninger for website-related costs. Other payments: \$250 to CPA, ESRI and awards expenses \$3,000 for students.
- Steve S. moved to allocate \$2,000 max for ESRI social under the assumption that URISA will contribute as well. An-min seconded. All approved.
- If URISA does not chip in, we can still send RSVP to our members.

#### 2. Standing Committee Reports:

#### A. Membership (Denise)

- 13 new members (10 came from Shasta College sustaining membership), 20 renewals, 1 non-renewal in last 2 months.
- Question: What if we have more than 10 ppl for sustaining education/non-profit?
   Propose tiers:
  - O New tier Up to 25 members \$500
  - o Currently, 10 members \$250
- Steve moved to approve new tiers for sustaining education/non-profit. Jochen seconded. All approved.
- An-min asked if we needed to update the bylaws to reflect tiers. We need to check.

#### B. Website (Norman, Steve S., Bond)

- Got in contact with Sara O'Hara (WP designer/website consultant) to revamp site
- Talked to Mark Greninger again about changing domain ownership. However, the paperwork to transfer ownership is too onerous so Mark will continue paying for now.

### C. Advocacy (Chris, Mihai, Mary)

- Isaac hasn't been on the CA Council meeting calls in the last 2 months so no updates on state GIO.
- What's the status of the merger with CA GIS Council? Will their members be paying members? Here are some thoughts:
  - Consider giving executive board 1 year free membership but everyone else will be regular paying members
  - Mary thinks that standing committees should be paying members
  - The onus is on CA GIS Council so the working group members need to join CGIA or be parentless b/c they are using the structure and services of CGIA to conduct their business
  - CGIA needs to be proactive. Reach out to working group leads letting them know that we want to support you but you need to become members
- Jochen volunteered to work with advocacy group to try to complete the merger involving talks with CA GIS Council.
- Chris will reach out to Jane and get some consensus and move things forward

#### D. Awards (Chris, Christine)

 Award nomination form announced. Reached out to some schools. Chris has no not seen any submissions.



- Chris R. contacted SD Trophy to make sure they are still in business and get the turnaround time. They have changed owners but still have our info and designs from past years. Turnaround time is 5 to 10 days.
- E. Elections (Dave, Steve K.)
  - Extended the elections an extra 2 weeks until June 19th.
  - Use of Election Buddy. Steve S. can set up again. There is a small cost.
