 - MySitePlan Lawsuit
 - Board of Surveyors has asked the owner who owns MySitePlan that they are in violation of CA law because they are performing surveying actions without licensure. Defendant represented by Institute of Justice.
 - We recognize that there needs to be some uniform standards/disclaimers for GIS professionals to use to clarify that the maps produced are not official and are not for surveying purposes
 - Depending on how the lawsuit goes, may have an opportunity to clarify statute
 - o Offer our assistance...teaming up with URISA
 - Bruce writing letter to NCEES clarifying differences between surveying and geospatial work that we do.
