- C. Advocacy (Jane Schafer-Kramer) August Meeting Notes
  - CDT & Staffer Correspondence (Jacob)
    - California Dept of Technology is working on state GIO position. Recruitment will start in Fall. Will NOT be at the same level as before. Before was middle management. New position will most likely be elevated executive position.
    - A Technology Innovation Advisory Council (TIAC) would be in place, but still working out details of who is represented.
  - URISA PAC & NSGIC Updates (Jane)
    - CGIA became a non-profit NSGIC member a few months ago.
    - NSGIC has become the forum for states to interact with USGS. NSGIC receives grant money from USGS to facilitate these conversations
    - Western States Caucus Best Practices for Common Operating Picture (COP). NSGIC is seeking out organizations that have built out systems to gather disparate data for the public.
